


FIG 1 ADM6-30-XX.X-XXX-4-X-A FOOTPRINT SHOWN




FIG 2 D ADM6-30-XX.X-XXX-4-2-A STENCIL SHOWN




FIG 3 ADM6-30-XX.X-XXX-4-0-A STENCIL SHOWN
